1. ACKNOWLEDGEMENT OF RISK. Participant, Parent(s), and/or Legal Guardian(s) acknowledge and fully understand that there are inherent risks of serious injury or death associated with clearing brush, moving branches, removing non-native species, encountering poison ivy, poison oak, and stinging nettle, unstable river beds, irregular or uneven ground and the like. Personal protective equipment deemed necessary, will be required to be utilized. It is necessary to have appropriate training, knowledge and/or experience in operating power equipment.

2. PARTICIPANT WAIVER OF RIGHTS AND RELEASE OF LIABILITY. The terms of this Agreement constitute the entire agreement and understanding between the parties. This Agreement is made pursuant to and shall be construed under the laws of the state of Michigan.
