 - i. There was a quorum who approved the budget and committee members
- d. Lenawee County Fair
 - i. Working on raffle license
 - ii. Also applying for the Monroe County Fair
- e. Upper River Raisin Aquatic Connectivity Project at the Brooklyn Dam
 - i. Chris Frieburger and Todd Losee from Niswander Environmental LLC are working to secure a grant from the US Fish and Wildlife Service to remove a high-hazard dam in Brooklyn Michigan
 - ii. The grant is from the National Fish Passage Program, and is \$25,000 of technical money to be spent this summer
 - iii. Niswander Environmental requests the RRWC to support the project, serve as the administrator of this fund, and act as the administrator to any future grant monies for this project. Motion by Kolon, seconded by Cooper.
 - iv. Comments from Bob Jensen and Jae Guetschow concering the project -Niswander Environmental will be introducing the project to Village of Brooklyn on June 14, 2021.
